## **15. EVALUATION OF CREDENTIALS FOR EMPANELMENT:**

The Firms / Agencies/ Contractor shall be empanelled with MRIDC based on their following details:

- Geographical Presence or Address (i.e. ease of accessibility of the Firm from Mumbai, Maharashtra).
- Year of establishment (Incorporation certificate to be attached).
- Similar works Completed by the Firm in last 7 Years counting from the last day of the preceding month in which EoI is invited.
- Length & No. of Bridges / Viaduct / Flyover, completed by the Firm in last 7 Years counting from the last day of the preceding month in which EoI is invited.
- Length & No. of Road Over Bridges (ROB) / Road Under Bridges (RUB) / Rail Viaducts / Rail Bridges, specially completed by the Firm in Railway portion in last 7 Years counting from the last day of the preceding month in which EoI is invited.
- Work in Progress with date of Award, Target Date of completion, Cost of work & Payment received till last day of the previous month in which EoI is invited (This statement shall be duly certified by Chartered Accountant).
- Financial Turnover (Construction only) / contract receipts during last 5 Financial years and the current financial year up to the end of the previous month in which EoI is invited.
- Average Annual Turnover (Construction Only) shall be calculated based on the Financial Turnover of last Five Financial Years. Year in which no turnover is shown would also be considered for working out the average turnover.
- Equipment, Plant & Machineries available with the Firm for the specific purpose.
- Self-certified copy of Bank Solvency Certificate issued from Nationalised or any Schedule Bank. The certificate should have been issued within 3 months from original last date of the submission of the EoI.

## Note:

- i) In case of Partnership Firm, each partner must provide jointly and severally, details of similar nature of work completed during last 7 Years counting from the last day of the preceding month in which EoI is invited, Work in Progress and Financial Strength in the Form Provided in EoI.
- ii) In Case of JV Firm, each member must provide details of similar nature of work completed during last 7 years, Work in Progress and Financial Strength in the Form Provided in EoI.

## **16. EVALUATION CRITERIA AND METHOD OF EVALUATION:**

The Shortlisting of Firms shall be done based on the marks obtained by the firm after evaluation of firm's experience, credentials etc. Screening of EoIs shall be carried out as per criteria decided by MRIDC and based on testimonials submitted. EoI will be evaluated for shortlisting inter alia based on their past experience of handling similar nature of work by the Firm during last 7 Years counting from the last day of the preceding month in which

EoI is invited, strength of their manpower & qualification, financial strength of firm, Work in Progress, Year of establishment, Geographical Presence, Equipment, Plant & Machineries available with the Firm for the specific purpose and presentation / proposal to the selection / evaluation committee whose decision will be final.

However, MRIDC reserves the rights to redefine the marking process & Evaluation Criteria based on the data provided by various agencies / Firms. In such situation MRIDC's decision will be final and binding.

## **17. SIMILAR WORK:**

Construction of Road Over Bridge (ROB) / Road Under Bridge (RUB) using Box pushing technic / Limited Height Subway (LHS) / Rail Viaduct / Road Viaduct / Rail or Road Bridges / Flyover with any Government, Semi Government, Public Sector Undertaking (PSU) organisation or any Private organisation of repute, shall be treated as similar work.

The firm may have experience of similar works through one contract or multiple contracts.

Applicant and in case of Partnership Firm each partner, jointly & severally must provide details of similar nature of work completed during last 7 Years counting from the last day of the preceding month in which EoI is invited.

In Case of JV Firm, each member must provide details of similar nature of work completed during last 7 years, Work in Progress and Financial Strength in the Form Provided in EoI.

All work experience and data provided should be substantiated by documentary evidence such as completion certificate / work order copy / LOA copy etc.
