SECTION 7

ELIGIBILITY AND QUALIFICATION CRITERIA

This section contains all the criteria that MRIDC will use to evaluate Bids and qualify Bidders through post-qualification. No other factors, methods or criteria shall be used other than specified in this bidding document. The Bidder shall provide all the information requested in the forms included in Annexures.

7 Evaluation

7.1 Adequacy of Technical Proposal

Evaluation of the Bidder's Technical Proposal will include an assessment of the Bidder's technical capacity i.e. experience of having executed similar nature of work and Financial Capacity as detailed in the following paras.

7.2 Eligibility Criteria:

The successfully completed / physically completed / substantially completed work experience certificate issued from Govt. / Semi Govt. / PSU/ Public listed company only will be considered for evaluation.

7.2.1 Technical Eligibility Criteria:

A. The Bidder must have successfully completed / physically completed / substantially completed any of the following during last **10 (Ten) years, ending last day of month, previous to the month in which tender is invited:**

Three **similar works** each costing not less than the amount equal to 20% of advertised value of the tender,

or

Two **similar works** each costing not less than the amount equal to 25% of advertised value of the tender,

or

One **similar work** costing not less than the amount equal to 40% of advertised value of the tender.

AND

B. Bidder must have Successfully completed / physically completed /substantially completed at least one **Cable Stay Bridge having span not less than 90 mtr** during last **10 (Ten) years, ending last day of month, previous to the month in which tender is invited.**

AND

C. Bidder must have Successfully completed / physically completed /substantially completed at least one work of **Steel Girder fabrication and erection of 1000**

MT and above in single span over Railway line during last **10 (Ten) years, ending last day of month, previous to the month in which tender is invited.**

AND

- D.** The Bidder must have agreement with renowned international stay cable agency to execute specialised stay cable supply and installation works. Such agreement must be exclusive and to be submitted along with tender submission.

AND

- E.** The Bidder must have agreement with renowned formwork manufacturing agencies with products which are DIN compliant for Pylon formwork. Such agreement must be exclusive and to be submitted along with tender submission.

7.2.2 Technical Eligibility Criteria for JV Firms:

In case of JV, either the JV firm or members of the JV firm individually or collectively must satisfy the Technical Eligibility Criteria defined above (Clause No. 7.2.1: A, B, C, D & E).

Each Member of JV should have adequate experience in Construction of Cable Stay Bridge **OR** Fabrication & Erection of Structural Steel Girder over Railway line during last 10 (ten) years, ending last day of month, previous to the month in which tender is invited.

Notes:

i. Definitions:

Successfully completed: It shall mean, that the work must be satisfactorily completed in all respect.

Physically completed: It shall mean, that the work should be physically completed in all respect, but the final bill may be under process.

Substantially completed: Value of work completed should be 80% or more of the latest contract value.

- ii.** The Contractor has to submit certificate duly verified by Client whether the work is **successfully completed or physically completed or substantially completed** and in case of substantially completed work, the issued certificate from client should clearly indicate the percentage completion of work with respect to the latest contract value.
- iii.** For successfully completed or physically completed works, value of work done shall be updated up to the end of previous month in which tender is invited from the month in which the work has been completed, in case of successfully completed

work or from the month in which the work has been physically completed, in case of physically completed work, assuming 5% inflation for Indian Rupees every year.

In case of substantially completed work, no updating of the value of work completed, as given in the clause above, shall be applicable.

The successfully completed / physically completed / substantially completed work experience certificate issued from Govt. / Semi Govt. / PSU / Public listed company only will be considered for evaluation.

The bidders having work experience certificate issued by Public listed company, following documents must have been enclosed along with offer, otherwise the particular work experience certificate issued by Public listed company will not be considered for evaluation:

- Proof of having average annual turnover of Rs 500 crore and above in last three financial years excluding the current financial year by Public listed company who have issued the work experience certificate.
- Along with the work experience certificate, the bidder must have submit, the relevant copy of work order, copy of final/last bill paid by company duly certified by Chartered Accountant in support of above work experience certificate.

iv. Similar Work: Construction of Cable Stayed Bridge / Road Over Bridge (ROB) / Rail Viaduct / Road Viaduct / Railway or Roadway Bridges / Flyover, with or without the portion within Railway boundary or over Railway track **with any Government, Semi Government, Public Sector Undertaking (PSU) or Public listed company shall be treated as similar work.**

7.2.3 Financial Eligibility Criteria:

The Bidder must have received contractual payments in the previous three financial years and the current financial year up to the end of the previous month in which tender is invited, at least 150% of the advertised value of the tender. The Bidders shall submit Certificates to this effect which may be an attested Certificate from the concerned department / client, Audited Balance Sheet duly certified by the Chartered Accountant.

In case of JV Firm, either the JV firm or lead member of the JV firm must satisfy the Financial Eligibility Criteria defined above and financial turnover of each other partner of JV (Excluding lead member) shall not be less than 10% of the financial eligibility as specified above.

7.2.4 Bid Capacity:

The Bidders must have available bid capacity equal to or more than the total bid value of the present tender. The available bid capacity shall be calculated as under:

$$\text{Available Bid Capacity} = [A \times N \times 2] - B$$

Where,

A = Maximum value of Civil construction works executed and payment received in any one financial year i.e. Current Financial Year & during the last three financial years immediately preceding the current financial year (current financial year ending last date of the month previous to the month in which tender is invited) taking into account the completed as well as work in progress.

N= Number of years prescribed for completion of work for which bids has been invited. If it is mentioned in number of days, in that case "N" will be calculated as number of days divided by 365 days.

B = Value of existing commitments and balance amount of ongoing works with the Bidder to be completed in next 'N' years. Proportionate value will be taken if the works falls during the different financial year.

Note:

- (a) The Bidder(s) shall furnish the details of existing commitments and balance amount of ongoing works with bidder as per the prescribed proforma of MRIDC for statement of all works in progress and the works which are awarded to bidder but not yet started up to the last date of the month previous to the month in which tender is invited. In case of no works in hand, a 'NIL' statement should be furnished. This statement should be submitted duly verified by Chartered Accountant.
- (b) The Value of Balance work will be linearly distributed to compute value of work to be executed during the period "N" years.
- (c) In case of JV, the Bidder(s) must furnish the details of existing commitments and balance amount of ongoing works with each member of JV as per the prescribed proforma of MRIDC for statement of all works in progress and the works which are awarded to bidder but yet not started up to the date of last date of the month previous to the month in which tender is invited. In case of no works in hand, a 'NIL' statement should be furnished. This statement should be submitted duly verified by Chartered Accountant.
- (d) Value of a completed work/work in progress/work awarded but yet not started for a Member in an earlier JV shall be reckoned only to the extent of the concerned member's share in that JV for the purpose of satisfying his/her compliance to the above-mentioned technical eligibility criteria in the tender under consideration.

- (e) The arithmetic sum of individual "bid capacity" of all the members shall be taken as JV's "bid capacity".
- (f) In case, the Bidder/s failed to submit the above statement along with offer, their/his offer shall be considered as incomplete and will be liable to be rejected.
- (g) The available bid capacity of Bidder shall be assessed based on the details submitted by the bidder. The Bidder shall calculate the value of work commitments in hand linearly, as given in Clause (b) above. However, if the details submitted is not according to linear calculation for work in hand, MRIDC will recalculate the same for the working out the value of Bid Capacity of the Bidder, and the same shall be acceptable and binding to the Bidder. In case, the available Bid Capacity is lesser than estimated cost of work put to tender, his offer shall not be considered even if he has been found eligible in other eligibility criteria as per the tender requirement.
- (h) Even though the bidders meet the above qualifying criteria, they are subjected to be disqualified if they have made misleading or false representation in the forms statement and attachments submitted as proof of the qualification requirements and / or record of post-performance such as abandoning the works, not properly completing the contract, inordinate delays in completion litigation history or financial failures etc.
- (i) In case, if the certificates regarding eligibility criteria submitted by the Firm / Agency is found to be forged / false or incorrect at any time during process of evaluation of Bids, it shall lead to banning of business with MRIDC for five years from the date of such order.
- (j) In case, if the certificates submitted by Firm /Agency is found to be false / forged or incorrect at any time after the award of contract, it will lead to termination of the contract, along with forfeiture of Retention Money and Performance Guarantee besides any other action provided in the contract including banning of business with MRIDC for five years from the date of such order.

7.3 Documents testifying bidder previous experience and financial status should be produced along with the tender.

Bidder(s) shall submit along with his / their tender:

- i. Certificates and testimonials regarding contracting experience for the type of job for which tender is invited with list of works carried out in the past.
- ii. Certificates which may be an attested Certificate from the client, Audited Balance Sheet duly certified by the Chartered Accountant etc regarding contractual payments received in the past.

- iii. Completion Certificate from respective Govt. / Semi Govt. / PSU issued by the officer not below the rank of Executive Engineer/ Authorized officer of the concerned organisation.

7.4 Specialized Subcontractors

If permitted under bid document, only the specific experience of Subcontractors for specialized works permitted by the Employer will be considered. The general experience and financial resources of the Specialized Subcontractors shall not be added to those of the Bidder for purposes of qualification of the Bidder.

MRIDC permits Bidders to propose Specialized Subcontractors for the following activities:

- a. General Electrification Works
 - b. Reinforced Retaining Earth Wall
 - c. Horticulture
 - d. Bearings
 - e. Aesthetic Finish
 - f. Installation of Cameras at sites
 - g. Pile testing & testing of materials
- Any other item of BOQ if approved by MRIDC
